FACILITIES Indoor show, facility is handicapped accessible, air-conditioned/heated, restrooms, booth spaces are 8' X 10' (no tents or canopies without consent). 8' tables (first 50) are available to rent and electrical is available, 4 receptacles per electrical "drop line". **Rental is based per receptacle.** If you require more than one receptacle please provide your own "power strip" or purchase additional receptacles (first 50) to rent.

Admission is free to the public. This is a NON SMOKING FACILITY. NO Pets allowed, certified service animals only.

Craft Fest is a juried show, no commercial, retail or non-handcrafted items will be accepted.

Applications are reviewed and accepted on a first come basis. Be aware, the shows fill early. There are a limited number of booth spaces available. When those spaces are filled, your application will be placed on a waiting list. **If this is the first time you have applied to participate in Craft Fest you must include photos of your work with your application, via e-mail to: mhcraftfest@gmail.com or text to 870-232-2113.** Vendor acceptance is based on the understanding that the vendor will sell only those items listed on their application. Additional items may not be sold without written consent/approval from Craft Fest. You will be asked to remove these items from your booth otherwise.

SEALED food items will be accepted (jams, canned foods, vinegars, etc.) All food items must be packaged for consumption OFF SITE. **Any approved food items MUST be labeled per the Arkansas Food Freedom Act (SB248).**

SALES TAX Collection of sales tax is required for all sales by the state of Arkansas. Forms will be included with your vendor packet. You are required to fill out and turn in these forms at the end of the show, or mail to: Pam Saltich c/o Arts and Crafts Gift Shop within 5 days. We will collect all forms and mail them for you to the state. If you have an Arkansas state resale # you may decline these forms and file Craft Fest Sales when you file your other sales.

CANCELLATIONS All cancellations must be received in writing 30 days prior to show dates to be eligible for a refund of fees. If eligible, entry and rental fees will be refunded by check only. We will not "forward" refunds to a future show. There will be a \$25.00 fee for any returned checks.

If you are accepted to participate, remember, booths should be attractive and inviting. All tables should be draped (preferably to the floor). No packing materials should be on view to the public.

Early departure from the show will prevent you from being accepted at future shows. This will be strictly enforced. All vendors must remain at their booths until the show closes at 4 pm on Saturday.
